Dear parents and carers of Stage 3,

Stage 3 students are invited to attend Jamberoo Action Park as an end-of-year excursion. This day has been allocated specifically to primary schools.

Students identified as non-swimmers or those who have not completed the swim survival challenge (see attached letter) will be issued with a non-swimmer band.

Date: Tuesday, 6 December 2022

**Time:** Departing school at 9.15 am. Students are at school by 8:50 am. After a fun-filled day,

we will return to school late at **3.45 pm**. An app message will be sent out to confirm the exact time on the day. It would be appreciated if parents arrive on time to pick up their

child once app message has been sent.

**Transport:** Seat belted coach

Cost: \$56.00 which includes entry and coach fare. If your child has a season pass, they are

only required to pay \$14.50 for the coach, however, they MUST bring their pass on the

day!

**Dress:** Also, include a set of dry clothes for return travel on the coach. Students are to come

dressed in their swimmers, and joggers (no thongs) and wear sensible sun-safe clothing (no singlets). Students are required to bring a hat and rash vest or t-shirt to wear during

the day. REMEMBER A TOWEL!

What to bring: Catering facilities will be available. Following school policy, students are asked not to

bring valuables (no phones or cameras).

Students will have to apply sunscreen every two hours. If they do not bring their own,

they will be required to use the school sunscreen.

When a medical practitioner has prescribed medication (including emergency medication) that will need to be administered during the excursion, parents are responsible for:

Bringing this need to the attention of the school

Ensuring that the information is updated if it changes

Supplying the medication and any 'consumables' necessary for its administration in a timely way. The medication should be well within its expiry date and in original packaging.

Collaborating with the school in working out arrangements for the supply and administration of the prescribed medication for the duration of the excursion. For some excursions the school will ask you to supply the medication in a different way to what has been already been agreed to by school. You may be asked to supply an additional Ventolin for example.
